# **GENERAL RULES**

#### **CONSTITUTION**

1.	The League shall be known as the Harrow and District Snooker and Billiards League (hereinafter abbreviated to HDSBL).
2.	The purpose of the HDSBL is to promote competitive Snooker and Billiards between local Organisations and their members.
3.	In all the HDSBL Rules, words implying the male gender shall equally apply to and include the female gender.
4.	The HDSBL shall be managed by a Committee consisting of a Chairman, General Secretary, Treasurer, Match Secretary,
	Competitions Administrator and up to seven members. All Committee members shall be elected at the Annual General
	Meeting. In addition, the President and Vice-President(s), having been proposed in the first instance by the Committee in
	recognition of past services, may attend Committee meetings in an advisory capacity with full voting rights. The Committee
	shall have the power to co-opt other members if deemed necessary. Any Committee Member failing to attend three
	consecutive Committee meetings without valid reason will be deemed to have resigned from the Committee.
5.	An Auditor to the HDSBL (who shall not be a member of the Committee) shall be elected at the AGM.
6.	A Member Club is defined as an autonomous group of players fielding at least one Snooker team in the HDSBL. A Member
	Club's name must be unique and is usually but not necessarily a derivative of the name of the Organisation/Venue where the
	Member Club plays its home matches. A Member Club's team(s) name(s) will consist of the Member Club's name plus a
	suffix of 'A', 'B', 'C' etc. to identify the team, 'A' being implied if absent.
7.	a) The Annual General Meeting of the HDSBL will be held as soon as is practicable after the last scheduled match of the
-	season. Notice of the AGM will be given on results sheets during the course of the season.
	b) A Special General Meeting of the HDSBL will be called, with notice of at least 14, and not more than 28 days, being
	given, if :-
	either ① a request, in writing, is received by the General Secretary bearing the signatures of the Club
	Representatives (as per the HDSBL Directory) of 5 Member Clubs. Notice of an SGM will be sent
	within 21 days of receipt of such a request.
	or (2) the Committee deems it necessary.
	The only business to be discussed at a Special General Meeting will be that on the Agenda.
	c) Each Member Club should have at least one delegate in attendance at an Annual or Special General Meeting and shall
	be entitled to one vote on any one issue (but see Rule 12).
8.	Each Member Club, or Organisation/Venue where the Member Club plays, shall subscribe annually towards the expenses of
	the HDSBL. The fees for the following season, including those that may already have been levied for any summer
	competition(s), will be proposed by the Committee for approval at the Annual General Meeting (see Rule 13 below). In the
	event of an appropriate entry fee not having been received by the League by 1st. September, the offending team(s)/player(s)
	may be excluded from the relevant competitions or have points deducted at the discretion of the Committee.
9.	The HDSBL's permanent trophies for all competitions will be presented to the winners at the end of each season and shall be
	handed back to an appointed Committee representative by the following 31st March. Recipients of these trophies (be they
	Member Clubs, Teams or Individuals) will be expected to replace any trophy, fully engraved, if lost whilst in their
	possession. The Committee will determine annually the numbers of and expenditure on individual trophies, which will also
10	be presented at the end of the season.
10.	The Committee reserves the right to arbitrate in the event of a dispute arising out of the interpretation of any General or
11	Competition Rule and its decision will be final.
11.	Penalties and/or allocation of points in the event of a breach of any General or Competition Rule will be decided by the Committee and its decision will be final.
12.	The League shall not be wound up, except by a two-thirds majority of those eligible, and voting at, a Special General
	Meeting called for the purpose. On the winding up of the League, the assets remaining after payment or discharge of all
	debts shall be disposed of as may be determined by a simple majority of all the Members present at the Special General
	Meeting at which the winding up decision was taken.
13.	Alterations to any General or Competition Rule can only be made at an Annual or Special General Meeting (see Rule 7
	above).
	A Proposal for consideration at the AGM must be
	either ① sent in writing or by email from any one of a Committee Member, a Member Club Representative, a team
	Captain or a recognised member (see General Rule 16) to reach the General Secretary at least 35 days prior to
	that meeting
	or ② submitted by the Committee.
	Club Representatives will be given details of all proposals (including proposed League fees) between 35 and 28 days prior to
	the AGM.
	An amendment to an original proposal must reach the General Secretary at least 7 days prior to the AGM. Any received after
	this date will not be accepted. The Committee may formulate an amendment to an original proposal from a Member.
	At the AGM an amendment will be voted upon first, and if not carried the original proposal will be considered. If more than
	At the AGM, an amendment will be voted upon first, and if not carried the original proposal will be considered. If more than one Amendment to an original Proposal is received, they will be considered in the reverse order of receipt.
	The Committee may make temporary amendments to these Rules to ensure the smooth running and financial security of the
	League. Any such amendments will be subjected to scrutiny (and possible permanent acceptance) at the next AGM.

In the event of a result not being received by the Competitions Administrator by 21:00 on a published "required by" date, either or both players may be scratched from the competition.
4.	Matches shall be decided over the best of three frames up to and including the semi-finals. The final shall be decided over the best of five frames.
5.	<ul> <li><u>Semi-finals and Final</u></li> <li><b>a.</b> These will normally be played on neutral tables. Officials for these matches will be appointed by the Committee.</li> <li><b>b.</b> A player not present when called to play will forfeit one frame and will forfeit one more frame for each subsequent 20 minutes of non-appearance.</li> </ul>

	The Handicap Sub-committee reserves the right to re-assess the handicap of any player at any time.
3.	A player may elect to play a home match at a different venue than that stated on the entry form, subject to the prior
	agreement of his opponent.
4.	All matches shall be arranged as soon as possible and by mutual agreement. It shall be the responsibility of the winning
	player to inform the Competitions Administrator of the result. In the event of a result not being received by the Competitions
	Administrator by 21:00 on a published "required by" date, either or both players may be scratched from the competition.
5.	All matches shall be decided over the best of 3 frames.
6.	Semi-finals and Final
	a. These will normally be played on neutral tables. Officials for these matches will be appointed by the Committee.
	b. A player not present when called to play will forfeit one frame, and if still not present 20 minutes after being called to
	play will forfeit both frames.
7.	Players shall toss for break in the first frame of each match and will then break alternately.
8.	Each round shall be separately drawn.
9.	In addition to the Rules above, the appropriate General Rules of the HDSBL will apply.

#### **BILLIARDS COMPETITIONS RULES**

1.	The Competitions shall take the form of two individual knockout Billiards tournaments (an Intermediate and the EDDIE
	RICHES Billiards Championship).
2.	A player may enter either or both competitions. However, the Billiards sub-committee reserves the right to reject an entry
	for the Intermediate competition if it considers a player's known ability would give him an unfair advantage. Intermediate
	competition semi-finalists will automatically qualify for the Championship.
3.	A player may elect to play a home match at a different venue than that stated on the entry form, subject to the prior
	agreement of his opponent.
